2. Declarations of interest for Items on the Agenda: None

- 4. Minutes of the Last Meeting: These were read and signed as correct.

5. Matters Arising:

Defibrillators – An electrician has advised that there is no power to the phone box in Inwardleigh and the defibrillator cannot be installed until this is rectified. Cllr White will contact BT to resolve this matter. With regards to the Folly Gate defibrillator, Cllr Timms will liaise with the electrician as she has been advised that it must have its own independent electrical supply. The defibrillators will be insured under the new Parish Council policy for the sum of £5000.00.

Allotments – 5 New Road has asked for an allotment that has become vacant. No one else has expressed an interest. It was agreed by all present that she should be offered this allotment, Cllr Dennis will notify her. Cllr Leech will check with West Devon to see if they own the allotment land and if so whether they would like to transfer ownership to the Parish Council.

1326/17/FUL The Golden Square Group

Single eco-dwelling to replace 2No. residential dwellinghouses given prior approval under LPA Ref. 00954/2015

Lower Eastwood Farm Okehampton EX20 3AE

The Councillors voted against this application as it would be a new build in the countryside and in a different location to the existing buildings that it would replace.

Householder application for roof extension and conversion of workshop and store to provide annex accomodation

The Councillors voted to support this application.

Application No.0219/17/FUL Westwood, Inwardleigh. Proposed hay/straw and machinery storage building. The Councillors voted in support of this application. Approved.

Application No.3897/16/FUL Rosewyn, Brightley Road. Conversion and link extension of two barns and change of use to dwelling. No decision to date. The Councillors voted against this application. The Councillors were concerned that the buildings were not structurally capable of a conversion and therefore would be a new build in the countryside. The proposed dwelling is located on a site where access is difficult and the installation of a septic tank with associated soakaway field would be undesirable due to the close proximity of the Okement river. No decision to date.

Application No DCC/ 3949/2017 Hill Barton Waste Water Treatment Works, Hill Barton, Sampford Courtenay, Okehampton, EX20 2RT. The Sewage treatment works - Prefabricated GRP building to house alkalinity dosing plant. The Councillors voted against this application and resolved to object due to, existing smell issues, which would only be exaggerated with the addition of another building and also the speed, volume and size of lorries accessing the site via a minor road. Granted.
